THE SECRETARY-GENERAL OF THE COUNCIL,

Having regard to the European Council's Rules of Procedure of 1 December 2009, and in particular Article 13(3) thereof and to the Council's Rules of Procedure of 1 December 2009<sup>2</sup>, and in particular Article 23(5) thereof,

Having regard to the Financial Regulation applicable to the general budget of the European Union (hereinafter "the Financial Regulation"),<sup>3</sup>

### Whereas:

- 1) The appropriations in Section II European Council and Council of the budget under Item 2200 (Travel expenses of delegations) cover the travel expenses incurred by the Presidency and delegations at meetings of the European Council and the Council as well as at meetings held within the European Council and the Council framework as defined in the Decision n°54/18.
- 2) For the application of Decision n°54/18 of the Secretary-General of the Council, it is necessary to take into account the withdrawal of the United Kingdom from the European Union as from first of February 2020 and the transition period in the share of the budget appropriations under Item 2200 for travel expenses of delegations.
